Pre-entries will be accepted on a "first received" basis beginning <u>Monday August 5, 2024</u>. No entries accepted prior to this date. Pre-Entries must be received by Trial Secretary by Tuesday <u>September 3, 2024</u>.

Day of Show Entries for Saturday and Sunday 8.00am - 8.30am

A fee of \$25.00 will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. Entry cancellations will be accepted up until September 3rd and full refund of entries made. Changes must be made to the Secretary by email or in writing. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial with a veterinarian's certificate prior to the start of the trial. No substitution of dogs will be allowed.

Dogs MUST be UKC registered: have a UKC Registration Number; or a Limited Privilege (LP); or Temporary Listing (TL) number in order to participate.

Entry Confirmation will be made as soon as practical after closing date for Pre-Entries. If you do not receive your confirmation by the Thursday preceding these events, please notify the Trial Secretary.

Indoors - Containers Master T1 then T2, Elite T1 then T2. We then move to Master Interiors T1 then T2, Elite Interiors T1 then T2.

Outdoors –, Master Exteriors and Vehicles T1 then T2, Elite Exteriors and Vehicles T1 then T2.

Competitors will run in posted order. At the discretion of the judge, trial volunteers may run their dogs before/after other exhibitors as needed. Move-ups will be permitted.

Awards:

- Placement ribbons will be offered First through Fourth in each element in the A and B Sections.
- New title ribbons will be awarded for new Element,
- New Title Rosettes will be awarded for overall Level titles, Champion and Grand Champion titles.

We can use your help! If you are willing and able to help Steward, it would be greatly appreciated. You may only steward for an element in which you are <u>not</u> competing. If you are able to volunteer your vehicle for any of the Trials, please inform the Trial Secretary.

IMPORTANT - PLEASE READ CAREFULLY

Canine Companion Club highly recommends that all exhibitors become familiar with the rules for UKC Nosework trials. The complete rule book is available to download from the UKC website: www.ukcdogs.com

Notice to Exhibitors

- 1. All events are held under the rules and regulations of the United Kennel Club, Inc. By entering this trial exhibitors acknowledge they are familiar with the rules and regulations of this sport.
- 2. Absolutely no alcoholic beverages or illegal drugs will be allowed on the grounds or building of a licensed UKC event.
- 3. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- 4. UKC, Canine Companion Club, their agents, and their club members assume no responsibility for any loss, damage, or injuries sustained by spectators or exhibitors, to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians. UKC, and Canine Companion Club are not responsible for loss, accidents or theft.
- 5. The "No Smoking" rule will be strictly enforced in the building and areas so designated.
- 6. Exhibitors and dog owners are expected and required to clean up after their own dogs. Any person witnessing a violation of this rule must report it to the Event Committee. The EVENT Committee may ask any person violating these rules to leave the event grounds. No refund will be made if the Exhibitor is asked to leave the grounds.
- 7. The UKC will vigorously support any motel that files a complaint about exhibitors that fail to keep their dogs quiet and/or fail to clean-up after them. In order that the bad conduct does not spoil it for the majority of responsibly exhibitors; UKC will take strong disciplinary action against any offenders.
- 8. Bitches in season, pregnant or lactating females may not compete. Ill dogs, dogs having sutures, bandages or anything indicative of a medical procedure, or dogs obviously in pain will be excused at the judge's discretion.
- 9. Dog and handler teams may arrive any time after 7:30 A.M. and prior to the morning judge's briefing and walk through. Awards are self-serve once available.
- 10. There will be no indoor crating for this event. **Dogs must be crated in their cars**. The only exception is when the dog is being pottied or proceeding to a search area.
- 11. Competitors will run in posted order. At the discretion of the judge, trial volunteers may run their dogs before/after other exhibitors as needed. Move-ups will be permitted. There will not be any reset offered.

GENERAL INFORMATION FOR FILLING OUT THE ENTRY FORMS

Entry Forms:

The official UKC Nosework Entry form must be used for all entries. Please inform the trial secretary if you are willing to volunteer for any elements in which you are not entered.

A and B Sections: Exhibitors must specify on the entry form either A or B section for each Element. Both sections will have the exact same search. If not indicated on the entry form, the entry will be placed in the B class.

<u>A Section</u> is for teams that are completely new to the sport and do not have a title in either UKC or an equivalent title in another organization, such as NACSW.

<u>B Section</u> is for all other teams. If you have an equivalent title in another Nosework organization, such as NACSW, AKC, CKC, CWAGS etc., you must compete in the B Section. If you are a licensed or professional dog trainer, Nosework instructor, or a person licensed to officiate in Nosework in any organization you must compete in the B section whether or not you have a Nosework title. Once you receive a title you can continue to show in the B section.

For your planning purposes: You need two (2) passes in an element to receive the element title. If you pass all 4 elements in a level they equate to Nosework Trial Level i.e. Novice Nosework, Advanced Nosework, etc.

From London: Take Hwy #402 W to Mandaumin Rd, turn left to Mandaumin, turn right at Courtright line, pass through Brigden, address will be on the left at the Canine Companion sign.
